Save-A-Life Ladder Extension

Access in and out of Roof Hatches can be stressful and pose a real threat of injury. The S.A.L. Ladder Extension mounts easily to all metal roof hatches and can be placed on either the right or left side of the hatch opening. All units are constructed with 1 1/2" X 1/4" steel vertical rails with 1/2" round horizontal rungs. Ladder extensions have a bright yellow epoxy finish*.

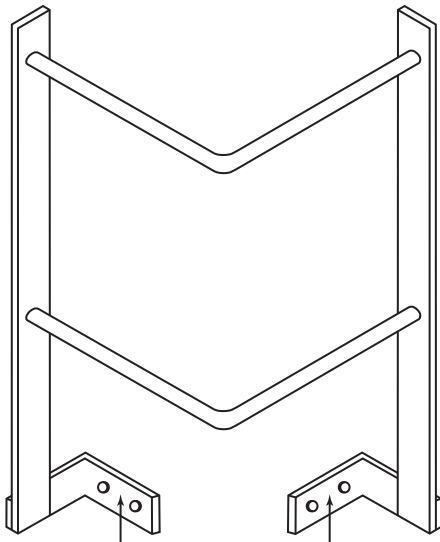

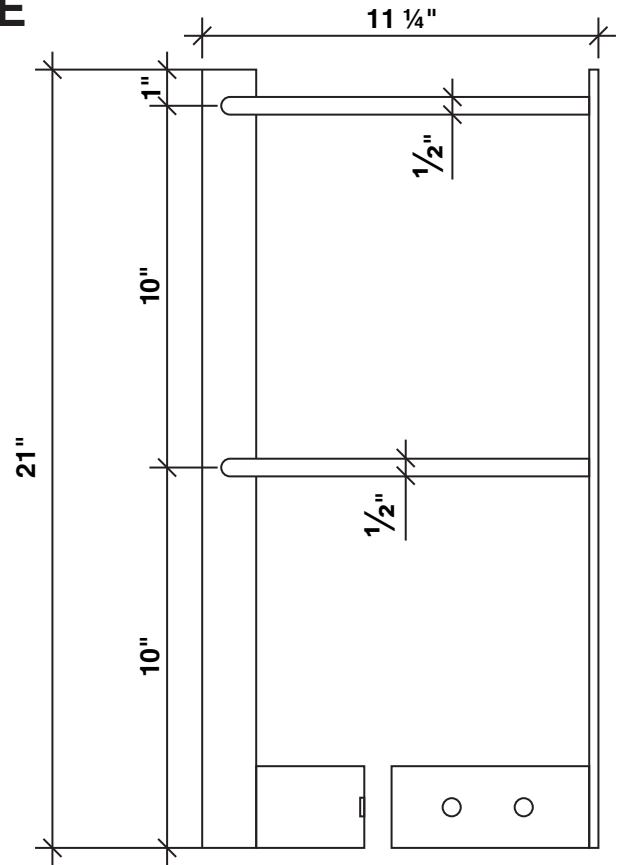

CONSTRUCTION

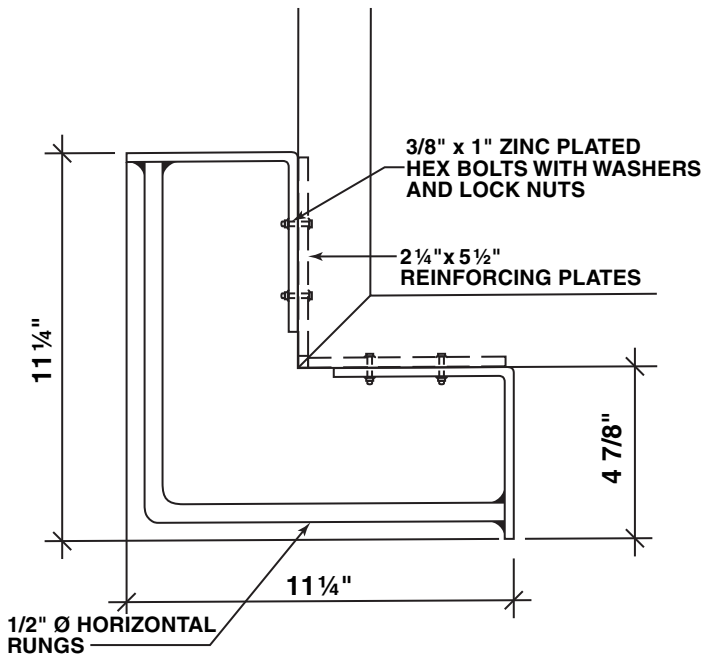
UNIT TO BE BRIGHT

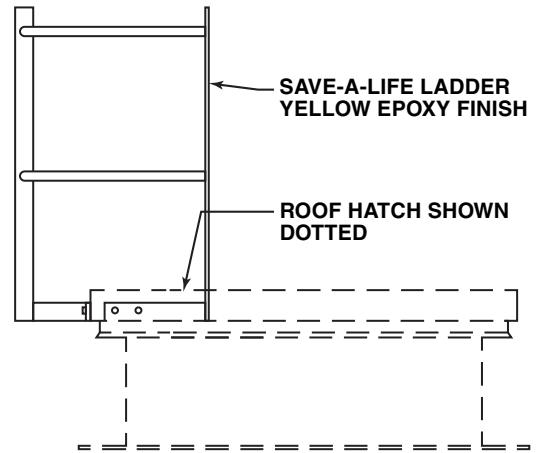
SIDE VIEW

SPECIFICATIONS

PART 1 - GENERAL

1.1 Scope

A. Furnish Save-A-Life ladder extension(s) as required.

1.2 Submittals

A. ___ copies of shop drawings shall be submitted to the architect for approval prior to fabrication.

1.3 Guarantee

A. A written guarantee will be provided certifying that the Save-A-Life ladder extension shall be free of defects in material and workmanship for a period of 5 years from the date of purchase.

1.4 Fabrication

A. One piece welded construction.
B. Unit shall be 21" overall height with 20" horizontal rails.
C. Unit(s) shall be supplied completely assembled and ready for installation.

PART 2 - PRODUCTS

2.1 Manufacturer

A. Save-A-Life ladder extensions shall be manufactured by Lane-Aire Manufacturing Corp., P.O. Box 4485, Carson, CA 90749. Phone number (323) 636-2324 or (714) 547-7744.

2.2 Materials

A. All units shall be constructed with 1 1/2" X 1/4" steel vertical rails with 1/2" round horizontal rungs.
B. Unit shall be bright yellow epoxy finished.
